There is no expressed or implied counselling, mentoring, coaching, psychological or psychiatric diagnosis or treatment or therapy, or couple's therapy - or any other form of intervention that would be ordinarily be provided by a psychiatrist, clinical psychologist, counsellor or coach. Definition of Terms

'Client' is the person who undertakes the Bespoke Personality assessment.

'Sponsor' is the person who commissions and/or pays for Bespoke Personality service and who is not the Client in receipt of the service.

'Bespoke Personality' is a trading name of Philip Corr Limited (Company No. 11259189).

'Service Contract' is the agreement made by the Client or Sponsor to commission the services of Bespoke Personality and is subject to acceptance of all Terms and Conditions.

'Service Provider' or 'Service Providers' is one or more companies who provide IT and other services to Bespoke Personality, including website provision, eBook software, and survey IT platform.

'Party' refers to Bespoke Personality, the Client or the Sponsor.

'Third Party' refers to any party (person(s) or organisation) that is neither Bespoke Personality nor the Client or Sponsor.

'Psycho-education' is knowledge, skills, strategies and other resources of a general psychological educational nature, and expressly excludes specific diagnoses, treatments and intervention conventionally provided by specialists in clinical or counselling psychology, medicine (including psychiatry), mentoring, coaching, couples/marriage counselling, and similar. Bespoke Personality provides psycho-educational services only, as defined above.

Summary of Principles and Practices

Bespoke Personality ensures:

- Client data are kept secure and any personal information held will not be identifiable an ID Code is used to link test scores, analysis and feedback, and this will be stored securely and separately.
- A Verification Name will be required for Bespoke Personality to respond to requests from any person holding the ID code.
- Clients can request anonymity and so, if preferred, do not need to provide their name or any other personally identifying information.
- Once the Feedback Report has been sent to the Client, their name will be deleted from electronic and written records, and only the ID Code and Verification Name will be retained for future reference.
- No Client information held by Bespoke Personality will ever be disclosed to a Third Party, unless required by legal process - save data automatically captured by our Service Providers.
- Adherence to the Laws of England and Wales.
- All data storage and handling are compliant with GDPR.

Information We Collect and Keep On You

When you register for BP services we may ask for personal information such as your name, gender, age, email address, occupation, contact details and other information – but you will be offered and can request anonymity (i.e., no Client name). When you complete the personality questionnaire we retain the test scores. Your scores are identified by a unique ID code, which does not contain your name, but which can be linked to you if you have provided your name – this linkage information will be held securely by BP. A Verification Name will be needed to release information to any person holding the ID Code.

Our Service Providers may record your activity when visiting their site(s) and they may collect other technical data, including browser type, IP address, time zone setting and location. (See below for further information on our Service Suppliers.)

We do not collect any Special Categories of personal data about you (as defined under relevant European data protection laws) - this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health, and genetic and biometric data. Nor do we collect any information about criminal convictions and offences. If such information is disclosed during any Feedback Consultation, or by any other means, this will not be stored and nor will it be used for any purpose other than that intended by the Client (e.g., establishing clarification or context during Feedback Consultation).

How We Use Your Data and Information

Any use of your personal data and information is in accordance with the extant laws prevailing in England and Wales.

Your data may be processed in order:

- 1. To maintain the website making its content relevant to you;

Cookies and Automated Technologies

All downloadable documents, files or media made available on this website are provided to users at their own risk. While all precautions have been undertaken to ensure only genuine downloads are available, users are advised to verify their authenticity using anti-virus software or similar applications.

Data Retention

We retain your personal data only for as long as it is necessary; for example, for the purposes of legal, accounting, or reporting requirements. When it is no longer necessary to retain your personal data, it will be securely deleted – however, your raw test data will be retained and we reserve the right to use it for statistical analysis.

Once we have provided you with your Feedback Report we will retain your personal data for only six further months and then it will be destroyed. You will have the unique ID code if you ever wanted to request further information or an additional service. We will ask you for a Verification Name before we release any information to you or any person requesting it with your unique ID code - this Verification Name will be set once you commission BP's services.

We have no control over the retention of data by our Service Providers. You are advised to read their Privacy Notice for further information.

Know Your Legal Rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data, including:

- Request access to your personal data and to receive a copy of the personal data we hold on you
- To check we are lawfully processing your personal data
- Request correction of your personal data
- Request deletion of your personal data
- Object to processing of your personal data you can object where we are relying on a legitimate interest (or those of a Third Party)
- Request restriction of processing your personal data.
- Request transfer of your personal data.

- 2.2. The Client and/or their Sponsor shall hold in trust and confidence all materials (e.g., Feedback Reports), and they are only to be used by Client and/or Sponsor and not shared with any Third Party or reused for any purpose whatsoever.
- 2.3. Each Party agrees to do its best and in good faith to keep confidential all Client information, data and the content of discussions shall be treated in absolute confidence.
- 2.4. No information shall be disclosed or allowed to be disclosed to a Third Party without written consent of the Client.
- 2.5. All services are provided by Bespoke Personality are in 'good faith'.
- 2.6. It will be in the sole discretion of Bespoke Personality whether the quality of service has been met.

3. Terms and Conditions of Payment

- 3.1 All rates are in pounds sterling (£) and exclusive of VAT. Invoices shall be issued in advance and shall be paid within 30 days from the date of invoice, unless otherwise agreed upon by both parties.
- 3.2 At least 50% of the full payment must be made before the personality assessment process begins and then full payment is made within 30 days of the date of transmission of the Feedback Report (whether by email or postal service).
- 3.3 The full fee is payable before any post Feedback Report Consultation (whether by video conferencing, or face-to-face meeting, or by any other means of consultation).
- 3.4 Any sums which remain unpaid following the expiry of the period set out in 3.1 & 3.2, here shall incur interest on a daily basis at 4% above the base rate of the Bank of England from time to time until payment is made in full of any such outstanding sums.
- 3.5 If the service is terminated by the Client at any time then fifty percent of any monies will be refunded upon cancellation between the payment and the start of the service.
- 3.6 The fee for any service commissioned, commenced and, therefore, deemed to be completed will be retained in full.

4. Terms and Conditions of Interruption, Termination and Cancelation of Service

- 4.1. All services will be provided within 6 months of their commission, as shown by the date of payment of the fee (whether part or in full) extension of this time limit will be at the sole discretion of Bespoke Personality.
- 4.2. The Client will be assigned a senior psychologist to undertake the assessment, statistical analysis, preparation of Feedback Report, and Consultation, and Bespoke Personality reserves the right to decide on this person(s), even after the Client has been informed that they would be serviced by a specifically named person it is expected that this reserved right would be exercised only in unavoidable circumstances (e.g., illness).
- 4.3. No Party shall be liable for any failure or delay in performing their obligations where such failure or delay results from any cause that is beyond the reasonable control of the Party such causes include, but are not restricted to: power failure, internet service provider failure, industrial action, civil unrest, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action or any other event that is beyond the control of the Party in question.
- 4.4. In the event that a Party cannot perform their obligations as a result of force majeure for a continuous period then the other Party may at its discretion terminate the service contract by written notice.
- 4.5. In the event of a termination of service, the parties shall agree upon a fair and reasonable payment for all services provided up to the date of termination this sum shall not exceed 50 percent of monies already paid to Bespoke Personality.
- 4.6. In the event that the Client unilaterally terminates the service contract, Bespoke Personality retains the right to retain all monies paid to it Bespoke Personality may also reasonably request further monies to be paid to cover any services already completed but not yet paid for.
- 4.7.
